**Direction issued by the Commission** This proceeding shall be read in continuation of the earlier proceeding of the Commission dated 30.10.2012. The Deputy Secretary (Home), Government of Arunchal Pradesh, Itanagar, has forwarded vide his letter dated 24.9.2012. It is intimated that compensation of Rs. 1 lakh each has been paid to each ten members of the public injured in the firing. Further, the investigation in the criminal case is still going on. Some other witnesses are yet to be examined and the medical reports of the injured are to be obtained from the concerned hospital. Some other actions mentioned below have also been taken on the recommendation of the enquiry committee :- I) The Deputy Commissioner, Roing, has been advised to hold periodical consultations with the public. II) Transfer of the concerned Executive Magistrate, Roing, is under process. III) The policy of posting of husband and wife as Deputy Commissioner and SP at the same place is under review. IV) The investigation of the case has been handed over to SIT. V) The Personnel Department has initiated steps to impart administrative training to the police officers and magistrates to control crowd, unlawful assembly to maintain law and order. The Commission has considered the above report. Action in accordance with law has been taken. Monetary compensation has been paid to the injured. The case is closed. Inform the complainant accordingly.
