With reference to your complaint dated 22/11/2011, I am directed to say that the matter was considered by the Commission on 28/09/2015. The Commission has made the following directions.

LINKED WITH CASE NO.2240/12/8/2011-PCD/DB-II

The Commission vide proceedings dated 5.4.2013 recommended to the Govt. of Madhya Pradesh to pay a sum of Rs. One lakh to the next of kin of the deceased Ansar Ahmed and submit compliance report alongwith proof of payment .

Pursuant to the directions of the Commission, Deputy Secretary, (GAD) Govt. Madhya Pradesh , vide communication dated 20.1.2014 has forwarded a copy of the receipt regarding payment of Rs. One lakh to the mother of the deceased Ansar Ahmed.

Since recommendation of the Commission has been complied with, the case is closed.

Direction issued by the Commission These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 07.10.2013. In response, the Addl. Secretary, Home Department, Govt. of Madhya Pradesh, vide his communication dated 23.12.2013 has submitted the report. Perusal of the same reveals that an amount of Rs. 1,00,000/- (Rupees One Lakh Only), as recommended by the Commission, has been sanctioned by the State Government and the Deputy Inspector General of Police, Bhopal City has been directed to submit the proof of payment made to next of kin of the deceased. The proof of payment has, however, still not been received. The Commission has considered the matter. Let a Notice be sent to the Deputy Inspector General of Police, Bhopal City, calling upon him to submit the proof of payment made to next of kin of the deceased within four weeks. The matter being death in police custody, be placed before the Division Bench.
