
Sub: Complaint from Shri Suhas Chakma , Director, Asian Centre for Human Rights alleged extra-judicial killing of three persons in Thoubal District, Manipur by personnel of 28 Assam Rifles and Police on 11<sup>th</sup> January, 2005.

Sir,

I am directed to refer to the NHRC's Summon No. 37/14/2004-2005-AF (M-5) dated 23-10-2008 in the matter of payment of compensation to the NOK of the two civilians deceased Shri S. Samungou Singh and Shri S. Ngongo Meitel, wherein Defence Secretary has been directed to appear in person before the Commission on 16-12-2008 at 11.00 A.M alongwith the Action Taken Report. It has also been stated that in case the report is submitted on or before 08-12-2008 the personal appearance of Secretary, Ministry of Defence shall be dispensed.

2. In this regard, It is stated that the payment of compensation amount of Rs. one lac each to the NOK of the two civilians deceased has been approved and sanction letter for the same has been Issued to the HQ Eastern Command by Army Hqrs (copy enclosed). The receipt from the NOK of the two civilians deceased for the said amount of Rs. one lac each towards proof of payment would be forwarded to NHRC immediately on receipt from the AHQ. The Commission is therefore, requested that personal appearance of Defence Secretary may be dispensed with.
