Direction issued by the Commission	The complaint pertains to alleged custodial rape of a woman by senior sub inspector Satyendera Sheel, the Station House Officer of Police Station in Ferozabad District of Uttar Pradesh. Pursuant to the directions dated 19.2.2009 of the Commission, SP, Ferozabad, vide communication dated 24.3.2009, has intimated that on the written complaint of Shri Pramod Kumar, case crime No.17/2009 u/s 376/504/506 IPC & 3(2)5 SC/ST Act was registered at PS Fariha, Ferozabad. The report further reveals that chargesheet has been filed against both the accused of the case and financial assistance of Rs.25,000/- has also been paid to the victim on 10.2.2009. The report also reveals that case crime No.18/2009 u/s 376(2) (a)/504/506 IPC was also registered against SI Satyendera Sheel and the same is under investigation. The Commission vide proceedings dated 8.5.2009 directed SP, Ferozabad, to submit status of case crime No.18/2009 within four weeks. However, no response has been received to Commission's letter dated 12.5.2009 conveying the above directions to SP, Ferozabad. Let a reminder be issued to SP, Ferozabad to submit status of case crime No. 18/2009 within four weeks failing which the Commission shall be constrained to invoke provision of section 13 of the Protection of Human Rights Act, 1993.
