Sir/Madam.

I am directed to say that the matter was considered by the Commission on 27/02/2013 and the Commission has directed as follows.

These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 9.1.2013.

In response, a letter dated 12.2.2013 has been received from Inspector General of Police CB/CID, Police HQrs., Uttrakhand, Dehradun along with the report received from Dy. Inspector General of Police, Dehradun Range, Uttrakhand. Perusal of the same reveals that Miss Anchat was neither tortured nor harassed by the police officials. She committed suicide. After completion of investigation in case crime No.5/12 final report has been filed in the court. It is further revealed that Miss Anchal committed suicide of her own and payment of compensation does not appear to be justified but if at the level of administration some compensation is paid the Police Department has no objection.

The Commission has considered the report as well as reply. In case crime No.5/12 final report has been filed in the court. The victim was alone in the custody of the police who was successful in committing suicide thus violating her human rights. An amount of Rs. 1,00,000/- (Rupees One Lakh only) is recommended to be paid as interim relief to the next of kin of the deceased. Chief Secretary, Government of Uttrakhand, Dehradun is directed to send the proof of payment made to the next of kin of the deceased to the Commission within four weeks.

It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 04/04/2013, so that the same could be placed before the Commission.
