<b>Direction issued by the Commission</b>	The Commission received a complaint dated 29.01.2014 from Shri Amal Kanti Chakma, Complaints Coordinator, Asian Centre for Human Rights, in which it is stated that one U.Ezhumalai, a farmer from Gandhi Nagar village of Thiruvainainallur in Vilupuram District of Tamil Nadu, and his friend Ayyappan were proceeding on a motorcycle. When they reached Emapurai, a Caste Hindu stronghold, a gang of seven upper caste people allegedly refused to give way to their motorcycle leading to altercation, which soon snowballed into a clash. U.Ezhumalai and Ayyappan were attacked with wooden logs and sharp stones. Ezhumalai sustained severe injuries on the head and throat and succumbed to the injuries on the spot. His friend who had also sustained injuries managed to escape. The incident took place on 16.01.2014. Vide its proceedings dated 25.02.2014, the Commission called for a report from the concerned authorities. Pursuant to the directions of the Commission, the SP, Viluppuram, has submitted his report dated 16.05.2014, in which it is stated that a case Crime No. 25/14 was registered U/S 147/148/341/323/324/302 IPC r/w (1) (x)/3(2) (v) of SC /ST Act. After completion of investigation a chargesheet has been submitted in the Court. It is further stated that Rs.3.75 lakhs have been given by the State Government to the next of kin of the deceased's family. During incident one Anandan @ Raja and Soundararajan had also sustained simple injuries when they tried to prevent the assault. Vide proceedings dated 11.07.2014 the copy of the above report was directed to be sent to the complainant for his comments. No comments have been submitted by the complainant. It is presumed that he has nothing to say in the matter. The Commission has perused and considered the report. As per the police report chargesheet has been submitted in the criminal case, which was registered regarding the incident and compensation has also been paid to the next of kin of the deceased's family. The complainant has not submitted any comments. It shows that he is satisfied with the action taken and report submitted by the police. In these circumstances, no further intervention of the Commission in the matter is required and the case is closed.
