
With reference to your complaint dated 19/04/2006, I am directed to say that the matter was considered by the Commission on 21/10/2010. The Commission has made the following directions.

*These proceedings shall be read in continuation to the Commission's earlier proceedings dated 30.06.2010 when it recommended that six injured persons whose names find place in the record of BSH be awarded the amount of compensation (Rs.50,000/- to each injured) and the compliance report with proof of payment be sent within six weeks.*

*In response, B.S.F., DIG(OPS) C vide communication dated 08.10.2010 has informed the Commission that as per direction of the Commission, Rs.3,00,000/- (Rupees Three Lakhs Only) to the NoK of the deceased late Gupalaya Chakma and Rs.50,000/- (Rupees Fifty Thousand only) each to six other injured persons, namely, Shri Ekanani (Smt. Thorngoloda), NoK on behalf of Shri Ekanani), Shri Bijoy Kanti, Juddhamuni, Amar Singh, Lakhi Kumar and Satya Priyain have been paid and photocopies of cash receipts duly countersigned by Additional Dy. Commissioner of District Lunglei as proof of payment have been enclosed.*

*Since on recommendations of the Commission, the required amounts of compensation have been paid to the NoK of deceased and six other victims and proof of payments have been received, the case is, therefore, closed.*

Sir/Madam,

I am directed to say that the matter was considered by the Commission on 11/11/2009 and the Commission has directed as follows.

*These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 29.4.2009 when it directed as under: -*

*"Let a reminder be sent to Secretary, Home, Ministry of Home Affairs, Govt. of India, impressing upon him to send the reply to show cause notice dated 03.3.2009 within a period of four weeks. A copy of show cause notice dated 03.3.2009 be also sent."*

*Pursuant to the directions of the Commission, DIG (Operations), Directorate General, BSF, New Delhi vide communication dated 18.5.2009 has sent the report which is reproduced below:-*

*"The accused personnel were tried by the General Security Force Court as per BSF Act and Rules and after claiming the case from police and following punishments were awarded:-*

*Shri Umed Singh Mehta, AC (Retd) has been awarded sentence for forfeiture of 10 years past service for the purpose of pension.*

*Insp N B Bhat has been awarded sentence for forfeiture of 3 years of service for the purpose of promotion.*

*As an immediate and long term relief to the aggrieved family, Shri Gyanabaran Chakma S/o Late Gopalya Chakma has been enrolled in BSF as "Safai Karamchari" and posted to 1 05 Bn BSF. He has been provided with a permanent livelihood to support the family of the deceased. There is no provision in BSF Act, 1968 and BSF Rules, 1969 to grant compensation to any victim". Deputy Secretary to the Govt. India, MHA (H.R.), vide communication dated 15.06.2009, has sent a copy of the same report of DIG (Ops), BSF.*

*The Commission has considered the facts & circumstances of the case. Secretary, Ministry of Home Affairs, Government of India is recommended to award Rs. 3,00,000/- as damages to be paid to the*

*next of kin of the deceased and Rs. 50, 000/- to each of seven victims injured during the firing made by the BSF personnel, u/s 18 (a) (1) of the Protection of Human Rights Act 1993. The compliance report & proof of payment be submitted within a period of six weeks.*

*A copy of the report dated 18.05.2009 be sent to Shri Gyanabaran Chakma son of the deceased for his comments, if any, response in six weeks.*


It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 30/12/2009, so that the same could be placed before the Commission.
