Sir/Madam,

The complaint dated 05/12/2011 received from TEJANG CHAKMA, COMPLAINTS COORDINATOR in respect of MAYA & OTHERS CHILDREN OF HARI RAM GAUTAM, was placed before the Commission on 23/05/2016. Upon perusing the complaint, the Commission directed as follows.

The matter rested thus when the Commission vide its proceedings dated 03.08.2012 had asked the state authorities to provide compensation to all the victims (5) of case Cr. No. 1351/2011, PS Chakeri, Kanpur, u/s 436, 307 IPC & S.3 (2) (v) SC/ST Act in which charge sheet had been put in court on 29.12.2011. Their attention was also drawn on the norms for relief as enumerated at serial No. 17 & 22 of the schedule (Annexure I) under the SC/ST Act & rules made thereunder. The victims have only been paid Rs. 6250 each as against Rs. 50,000/- each.

Pursuant to further directions of the Commission vide proceedings dated 05.05.2015 and 27.07.2015, the District Magistrate, Kanpur Nagar, UP vide his communications dated 18.05.2015 and 03.09.2015 has submitted that an amount of Rs. 50,000/- each has been paid to all the victims and further Rs. 10,000/- has also been paid towards loss of belongings to one of the affected victim.

The Commission has considered the matter. The prescribed amount of financial relief as mandated under law has been paid to all the victims. The law is taking its own course in the matter. No further action is called for. The Reports are taken on record & the case is closed.

2. Accordingly, I am forwarding a copy of the complaint for necessary action as per the directions of the Commission.
