Superintendent of Police, Badwani, M.P. sent a fax message to the Commission on 18.6.03 regarding the custodial death of Khemla s/o Radhu Barela aged 30 years in custody of Police Station Gumadia Khurd. Deceased was a scheduled tribe. He further informed that in the Magisterial enquiry Circle Officer Police Shashi Kant Shukla, ASI Bhishma Singh Kushwaha, Head Constable/21, Mansha Ram and C/147 Kishor Patidar were found prima facie guilty of custodial torture, therefore, a FIR case Crime No. 53/03 u/s 302/323/34 IPC was registered for investigation by Additional S.P. Dharmendra Chaudhary. The Commission took cognizance of the matter on 7.7.03 directing the DG(I) to collect requisite reports from concerned authority in four weeks. All the reports pursuant to the directions of Commission were submitted. Inquest was done on 16.6.03 by SDM Badwani and prepared the report vyherein he has not

menfioned the injuries in detail and finding the cause of death unascertainable, he recommended autopsy. The autopsy was done on 16.6.03 and the report thereof reveals large number of injuries on the body of deceased and the cause of death is recorded as "due to shock and cyncape because of extensive multiple injuries which are homicidal in nature. Duration of death is about within 24 hours". The Magisterial Enquiry Report confirms the allegation of custodial

torture resulting into the death of deceased. Superintendent of Police, Badwani vide his letter dated 19.6.03 informed the Commission that a case was registered against these erring Police officers. The accused persons were Dy. SP, Shashi Kant Shukla, ASI Bhishma Singh Kushwaha HIC Mansha Ram and CIT Kishore Patidar. All were put under suspension and departmental action was also initiated against them. The case was handed over to the neighbouring District Jhabua to be investigated by the, Additional SP, Dharmendra Chaudhary. Additional D.G.P. (Complaint), Police H.Q., Bhopal, M.P. vide its letter dated 28.8.03 informed that compensation of Rs. 2 Lacs was given to the next of kin deceased but no proof thereof has been submitted. Thereafter, Superintendent of Police, Badwani vide, is letter dated 4.12:05 informed the Commission as the Investigating Officer Additional S. P. did not find any Police officers quilty of custodial torture, therefore, final report was submitted and all the Police officials were reinstated. Final report was accepted by the Court on 19.8.05, however, he has further informed that departmental proceedings have been initiated against the errant Police officials. Superintendent of Police,

Badwani" M.P. be asked to submit the status report of departmental proceedings also the proof of payment of compensation to the next of kin of

deceased to the Commission within four weeks.
