Sir/Madam,

With reference to your complaint dated 23/04/2013, I am directed to say that the matter was considered by the Commission on 05/10/2017. The Commission has made the following directions.

The Commission considered the matter (Case No.1328/13/2013-AD) on 15.6.2017 when it observed and directed as under:-

"The Commission received a complaint dated 23.04.13 from Shri Tejang Chakma, Complaints Coordinator, Asian Centre for Human Rights, New Delhi, regarding the custodial death of one Mohammad Khan in Chembur PS, Mumbai, Maharashtra on 16.03.13. The Commission took cognizance of the said complaint and called for the reports.

Pursuant to the notice various reports were received by the Commission and those reports were analyzed by the Investigation Division. From a report received from the DCP, Crime Branch, Brihan, Mumbai it is revealed that the complainant (Sh. Tejang Chakma) inadvertently mentioned the name of the deceased as Mohammed Khan in place of Naushad Mohd. Usman Sheikh. Reports received from concerned authorities also mention the name of the deceased as Naushad Mohd Usman Sheikh.

Registry has brought to the notice of the Commission that an intimation regarding the death of Naushad Mohd. Usman Sheikh was received from the DCP, Zone-VI, Chembur, Mumbai and was registered as Case No. 848/13/16/2013-PCD. Two more complaints were also received. These complaints were registered as Case Nos. 1674/13/16/2013-AD and 2501/13/16/2013-AD.

Vide proceedings dated 23.11.16, the Commission after considering reply to the show cause had already recommended to the Chief Secretary, Govt. of Maharashtra requiring him to make a payment of Rs. Five Lakhs as monetary relief to NoK of the deceased and send a compliance report along with proof of payment within six weeks.

Five Lakhs as monetary relief to NoK of the deceased and send a compliance report along with proof of payment within six weeks. In view of the above, Case No. 848/13/16/2013-PCD shall be the main case and all Cases i.e. 1328/13/16/2013-AD, 1674/13/16/2013-AD and 2501/13/16/2013-AD to be clubbed with this case. Issue reminder to the Chief Secretary, Govt. of Maharashtra to submit compliance report along with proof of payment of Rs. Five Lakhs as monetary relief to the NoK of the deceased Naushad Mohd. Usman Sheikh within six weeks positively. Put up on 24.06.16
