Sir/Madam,

With reference to your complaint dated 15/07/2011, I am directed to say that the matter was considered by the Commission on 16/03/2012. The Commission has made the following directions.

These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 31.10.2011. The Commission on 31.10.2011 observed and ordered:

"On the basis of the above, the District Judge, Pali, Rajasthan be requested to send a copyof the Magisterial Enquiry Report being conducted by the Addl. Chief Judicial Magistrate, Pali."

SP Pali to submit copy of the Viscera Report.

DG/CID to submit outcome of the Investigation of CB/CID.

District Magistrate, Pali tosubmit proof of payment of money and copies of sanction orders of the above mentionesd facilities to the next of the kins of the deceased.

Response within six weeks.

Pursuant to the directions of the Commission, District Magistrate Pali on 17.11.2011 informed the Commission that the State Government of Rajasthan had issued orders on 13.7.2011 and a sum of Rs. 5 lakhs have been sanctioned from the Chief Minister's fund and Rs. 2 lakhs have been sanctioned under the SC/ST Act and Rs. 50,000/- have been paid by the Ministry of Home, Government of Rajasthan for providing free of cost food stuff for 3 months and one LIG House have also been allotted. The District Magistrate have enclosed the proof of payment of Rs. 7 lakhs 50 thousand.

SP, CID(CB) Rajasthan, Jaipur on 12.12.2011 informed the

Commission that the CBCID Enquiry is still pending. He has also enclosed details of Charge sheet No. 89 of Case No. 101 of 2011 under Section 143/342/330/302 IPC and also under Section 3(1)(X), 3(2)(V) SC/ST Act PS Guda Aandla, District Pali in which has been submitted that charge sheet has been submitted against the police officials.

On the basis of above, since the Charge sheet has been submitted by J.O. against arrant police officials and 7 lakhs 50 thousand have been paid to the next of the kin of the decease along with a LIG house, their appears no need to peruse the Magisterial
