Sir/Madam,

I am directed to say that the matter was considered by the Commission on 23/06/2011 and the Commission has directed as follows.

These proceedings shall be read in continuation of the earlier proceedings of the Commission dated

The matter rested thus when an undated letter of April 2011 has been received from Dy. Secretary to the Government of Maharashtra, Home Department, Mumbai. Perusal of the same reveals that challan has been filed in the court against accused Dhananjay Madne, a police Constable. He has been placed under suspension. He has not done the alleged act while on duty or while victim in his lawful custody. It, therefore, cannot be said that the state is liable to pay compensation. It is only after the accused is convicted, the concerned court has to consider grant of compensation. The Commission is therefore, requested to drop or defer the proceedings.

The Commission has considered the report. It is not disputed that accused Dhananjay Midne is a Constable. It was his duty to prevent commission of any crime rather he himself perpetrated the crime on hapless victim Shweta Ramdas Nandi in the presence of her friend Arshad Hassan Ali. The human rights of the victim have been violated. In these circumstances, the Commission feels that grant of interim relief to the victim is justified. An amount of Rs. 25,000/- (Rupees Twenty Five Thousand only) is recommended to be paid as monetary relief to the victim. Chief Secretary, Govt. of Maharashtra, Mumbai is called upon to send the proof of payment made to the victim. Response in four weeks.

It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 03/08/2011, so that the same could be placed before the Commission.
