With reference to your complaint dated 10/09/2007, I am directed to say that the matter was considered by the Commission on 09/08/2011. The Commission has made the following directions.

These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 8.6.2011 wherein the Commission had inter-alia observed and directed as under:-

"Let a final reminder be sent to Secretary, Ministry of Defence, Govt. of India, South Block, New Delhi calling for the proof of payment within four weeks, failing which the Commission shall resort to Section 13 of the Protection of Human Rights Act, 1993."

Pursuant to the directions of the Commission, District Magistrate, Imphal, West District vide communication, dated 27.5.2011 has informed that a sum of Rs.25,000/- (Rupees twenty five thousand only), as an interim relief, as recommended by the Commission has been paid to the victim Sh. Soraisham Gopeshor Singh vide cheque No. 062983 dated 27.5.2011. The proof of payment has also been annexed with the report.

The orders of the Commission have been complied with. No further action is called for. The proof of payment is taken on record and the case is closed.

A copy of these proceedings be also sent to the Information Officer, NHRC and also to the recipient.

Sir/Madam,

I am directed to say that the matter was considered by the Commission on 04/02/2010 and the Commission has directed as follows.

The Commission vide proceedings dated 9.12.09 ordered and directed as follows:-

"Pursuant to the said directions, Show Cause Notice dated 14th October 2009 was sent to the Secretary, Ministry of Defence, Government of India, South Block, New Delhi. But no response has been received so far. Let final reminder be sent to the Secretary, Government of India, South Block, New Delhi calling upon him to send reply, as to why monetary relief be not recommended to be paid to the victim u/s 18 (a) (i) of the Protection of Human Rights Act, 1993 within four weeks failing which the Commission shall presume that the Government has nothing to say in the matter and will proceed on merit."

Pursuant to the said directions, reminder dated 11.12.09 was sent to Secretary, Ministry of Defence, Government of India, South Block, New Delhi calling for reply to the show cause notice. No response has been received. It appears that Government has nothing to say in the matter. In these circumstance, an amount of Rs. 25,000/- (Rupees Twenty Five Thousand only) is recommended to be paid as monetary relief to victim Soraisham Gopeshor Singh. Secretary, Ministry of Defence, Govt. of India, South Block, New Delhi is directed to send proof of payment to the Commission within eight weeks.

It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 12/04/2010, so that the same could be placed before the Commission.
