Amrita Sudan Chakrabortty, Founder, Manab Human - an NGO based in District Burdwan, West Bengal, by his email dated 16.01.2013 has forwarded a copy of press report captioned "One Youth killed in police firing in Shimla" (hat appeared in 'The Times of India' on 11.1.2013. According to the press report, a 26 year old Udayveer Singh was killed and another person named Harsh Sharma was injured after the cops fired at them at Taradevi in the outskirts of Shimla on 9.1.2013. The Commission took cognizance of the matter and issued notice to DGP, Himachal Pradesh, DM and SSP, Shimla and called for an explanation/requisite reports. Pursuant to the notice, the Commission received MER from Enquiry Officer-cum-ADM (L&O). Shimla. After considering the various reports, the Commission Issued a notice to the Government of Himachal Pradesh to show-cause why suitable monetary reliaf should not be recommended to be paid to the NOK of deceased Udayveer Singh and to the injury certificate of Harsh Sharma to the Commission and what action has been taken against the delinquent police officers for negligence of their dulles. Pursuant to the directions of the Commission, DGP, Himachal Pradesh vide communication dated 20.9.2013 has informed that as per the magisteral inquiry conducted by ADM (Law & Order), Shimla, Constable Ranbir Singh had exceeded the power vested in him under the law and not acted in a prudent and reasonable manner. If the police officials had acted diligently, the firing could have been avoided. Instead of resorting to any other form of force, they resorted to firing and It resulted in the deceased Uday Singh.
