Direction issued by the Commission	In response to the recommendation of the Commission, the Govt. of Manipur, Secretariat, Home Department vide communication dated 20.03.18 has informed that compensation to the tune of Rs. Five Lakhs each has been provided to the (i) Najma w/o late Md. Islamuddin of Lilong Chingjao and (ii) Apikcha Shahani w/o late Md. Fazal @ Sanyasi of Lilong Heinnou Makhang under Trouble District. The proof of payment has also been submitted. In view of the compliance of recommendation made by the Commission, the case is closed. The CD of the post mortem in this case, if any, available on record shall be sent to the concerned authority.
