Changsan, Principal Secretary, Women Political Department, Government of Assam who is representing the Government of Assam submitted that these reports are produced before the Commission by the concerned officer. Nevertheless, Ms. L.S. Changsan has fairly submitted that the case in toto was considered by the Government and after a decision was taken to pay a sum of Rs. 5 Lakhs to each of the next of kin of the deceased, sanction orders were issued and payment have also been made to the next of kin of the deceased. However, the sanction order and proof of payment are not produced before the Commission and the officer has fairly submitted that the same will be submitted to the Commission by tomorrow. According to the above statement and also considering the fact that the Government on its own had paid Rs. 5 Lakhs to the next of the kin of each of the deceased inclines to close the case. No further proceedings are necessary.
