Action Taken

On the basis of a press report appeared in the 'Indian Express' dated 27.06.2013, the complainant alleged that two inmates (teenage girls around 17 years) of Karnal Nari Niketan were found hangling Inside the bathroom of Karnal Nari Niketan on 26,06,2013. It was alleged that they committed suicide by hanging themselves from a water supply pipe in the ballhroom. The girls belonged to Kaithal and Mahendergarh. They were brought to the shelter home in June 2013 Pursuant to the directions of the Commission, the District Collector, Karnal vide communication dated 22,05.2014 sent a report of Magisterial Inquiry conducted wis 176 (1A) Cr.P.C. regarding the death of inmates Jyoti and Rajbala at Nari Niketan, Karnal. During enquiry it was ascertained that earlier both of them were kept in Nari Niketan on 23.06.2013, but they fled away from there on 24.06.2013. They were apprehended by the police from Kalthal and were again restored in

Nari Niketan, On 25.06.2013, they committed sulcide by hanging. No foul play was found and there was no reason for any suspicion. From the report of posimortem and from the forensic science laboratory report, rape was not proved. They had breakfast in the morning and lunch on 25.06.2013. In the evening after 4.30 p.m. they were found dead. They committed

suicide by hanging. Having considered the material placed on record, the Commission recommended a monetary relief of Rs.3,00,000/- each to be paid to the NOK of the deceased girls. In response, the Director, Women and Child Devl. Department, Haryana, Panchkula, vide his letter dated 19.05.2016 informed that the recommendation of the Commission has been complied with by paying Rs.3,00,000/- each to the NOK of the deceased girls Km. Rajbala and Jyoti. Proof of payments has been annexed with the report. The Commission has perused and considered the material placed on record. Since the directions of the Commission have been complied with, there is no need of any further intervention of the Commission in the matter. The case is closed. These proceedings shall be read in continuation of the earlier proceedings. The Commission has come across a distressing press report captioned, "Bodies of 2 Nari Niketan girls found hanging in bathroom" that appeared in the Indian Express 'dated 27.06.2013. The press report alleges that two inmates (leenage girls around 17 years) of Karnal Nan Niketan were found hanging inside the bathroom on 26.06.2013. It is alleged that they committed suicide by hanging themselves from a water supply pipe in the bathroom. The report further mentions that the girls belong to Kaithal and Mahendergarh. They were brought to the shelter home in June 2013. Vide proceedings dated 06.12.2013, the Commission considered the report from SP, district Karnal, Haryana that Kumari Rajbala d/o Shri Ram Kumar t/o district Mahendergarh had left her house with Kuldeep on 17.06.2013. In this regard an FIR No. 237/13 dated 18.6.2013 u/s 363/366A IPC was registered. She was recovered and produced before the Judicial Magistrate and under directions of the court she was lodged at Nasri Niketan, Karnal on 22.6.2013. Jyotl d/o Ramphal had left her home with Tejveer on 11.06.2013 and In this regard FIR No. 74 dated 20.06.2013 u/s 363/366A IPC r/w SC/ST Act was registered at police station Kalayat, district Kaithel. She was recovered on 17.06.2013 and by the orders of the Magistrate she was also lodged a Naarl Niketan, Karnal. Both the girls Kumari Rajbala and Jyoti escaped from the Naari Niketan on 23.06.2013 between 1.00 and 1.30 p.m. Regarding this, on the statement of Smt. Sandhya, Supdt. Naari Niketan, Kamal an FIR No. 485 dated 23.06.2013 u/s 225B IPC was registered at police Civil Lines Karnel, Haryana, Both the girls were traced on 24.06,2013 by the order of the court. They were sent to Naari Niketan, Karnal. Both the girls had committed suicide by hanging in the same bathroom on 25.06.2013 and in this regard a judicial inquiry is being conducted. Vide proceedings dated 25.04.2014, the Commission considered the report from SP, Karnal, Haryana that in FIR No. 485/13 u/s 225B IPC, a cancellation report had been filed. The Commission has also received a further communication dated 12.03.2014 from DGP, Haryana that the matter is pending investigation by State Crime Branch. The Commission directed: - 1. DGP Haryana to submit the requisite report of investigation by State Crime Branch, 2. The District Magistrate, Karnal to submit the requisite inquest report, post-mortem and cause of death of 2 deceased girl who committed suicide in the Nari Niketan, Karnal. In response to the directions dated 25.04.2014, the requisite report from DGP, Haryana is still awaited.

Direction issued by the Commission

The District Collector, Karnal vide communication dated 22.05.2014 has enclosed a report of Magisterial Inquiry conducted u/s 176 (1A) Cr.P.C. regarding the death of Inmates Jyoti and Rajbela at Narl Niketan, Karnal. The report mentions that from the evidence of witnesses and attending circumstances from PMR and other documents, it has been concluded that;- "Earlier both of them were kept in Nari Niketan on 23.06.2013, they fled away from Nari Niketan and on 24.06,2013 they were apprehended by the police from Kalthal and they were again restored in Nari Niketan. On 25.06.2013, 'they committed suicide' by hanging. No foul play was found on the spot. There was no reason for any suspicion. There was no reason to raise suspicion of any murder or any other offence. There are no suspicious circumstances attending their death and only one conclusion can be drawn is that "they committed suicide by hanging". From the report of postmortem and from the forensic science laboratory report, rape is not proved. They had breakfast in the morning and lunch on 25.06.2013. In the evening after 4.30 p.m. they were found dead". The Commission has considered the material placed on record. The Commission observes that as Jyoti and Rajbala committed suicide in the bathroom by hanging, the detaining authority, the management of the Nari Niketan had not taken adequate precaution to prevent the two girls from harming themselves. Issue a Show Cause Notice to the Government of Haryana through its Chief Secretary as to why monetary relief of Rs.3,00,000/- u/s 18 of the Protection of Human Rights Act, 1993, be not recommended to be paid to the next of kin of each of the deceased.
