Action Taken:

These Proceedings are in continuation of Commission's earlier Proceedings, on the allegation that, on 15th June 2013, a tribal woman, aged 19 years, who was returning home after work was offered lift by Ajay and Sonu. When she refused, she was forcibly dragged in the vehicle and taken to an isolated place, where she was gang raped by them. The Commission, vide its Proceedings of 13th October 2017, directed the Superintendent of Police, Jashpur, to send a report on payment of monetary relief under the provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995 to the victim of FIR No. 93/13 under Section 376(2)(G) IPC r/w Section 3(1)(xii) and 3(2)(v) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act of PS Bagicha, District Jashpur, Chhattisgarh. In response, the Superintendent of Police, Jashpur, Chhattisgarh, vide communication dated December 12, 2017, forwarded a report dated November 30, 2017 of the Assistant Commissioner, Tribal Development, Ambikapur, District Sarguja, Chhattisgarh. As per the report, Rs. 60,000/- was sanctioned for payment to Smt. Sampati Bai, wife of Shri Sundar Sai, but she has not turned up to receive the amount of relief. Having considered the report, the Commission, vide its Proceedings of 19th March 2018, directed as under: "The Superintendent of Police, Jashpur, is directed to send, within six weeks, a report on status of payment of monetary relief under the provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995, to the victim Smt. Sampati Bai, wife of Shri Sundar Sai of FIR No. 93/13 under Section 376(2)(G) IPC r/w Section 3(1) (12) and 3(2)(5) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act of PS Bagicha, District Jashpur, Chhattisgarh. Let copies of the report dated December 12, 2017 of the Superintendent of Police, Jashpur, Chhattisgarh, and report dated November 30, 2017 of the Assistant Commissioner, Tribal Development, Ambikapur, District Sarguja, Chhattisgarh, be sent to the victim Smt. Sampati Bai, wife of Shri Sundar Sai for her comments, if any, which should be received in the Commission, within six weeks." The Commission, vide speed-post dated April 24, 2018, got transmitted a copy of the report to the Complainant for her comments, if any, but, she has sent none. The Commission presumes that the Complainant has nothing more to urge in the matter in view of the report. No report with regard to payment of monetary relief under the provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995, to the victim has been received from the Superintendent of Police, Jashpur, Chhattisgarh. Issue a reminder to the Superintendent of Police, Jashpur, Chhattisgarh, directing him to send, within six weeks, compliance report along with proof of payment of the already sanctioned monetary relief under the provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Rules, 1995, to the victim Smt. Sampati Bai, wife of Shri Sundar Sai of FIR No. 93/13 under Section 376(2)(G) IPC r/w Section 3(1)(12) and 3(2)(5) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act of PS Bagicha, District Jashpur, Chhattisgarh. Inform the victim, Smt. Sampati Bai to receive the amount of monetary relief from the concerned authority.
