| Direction issued by the Commission | Considering the various reports particularly the Magisterial Enquiry Report holding the responsibility of the death of a deceased by Mizoram Police the Commission vide its proceedings dated 14.12.17 had issued Show Cause Notice to the Govt. of Mizoram through its Chief Secretary for a sum of Rs. Three Lakhs as monetary compensation recommended to be paid to the NoK of the deceased, Shebaram Reang. In response to the Show Cause Notice the Dy. Secretary to the Govt. of Mizoram, Home Department vide his communication dated 26.03.18 has submitted a detailed reply and had requested for re-consideration of the Show Cause Notice. The Commission has considered the above report in detail. The reasons adduced by the Commission in its proceedings dated 14.12.17 were based on a detailed analysis of various reports by the Investigation Division of this Commission, particularly placing heavy reliance on the MER. Therefore, the Commission is not inclined to accept the reasons given in the report and accordingly confirms its show cause notice and recommend to the Chief Secretary, Government of Mizoram to pay a sum of Rs. Three Lakhs as monetary compensation to next of kin of the deceased Shebaram Reang. The Chief Secretary, Govt. of Mizoram shall submit compliance report along with proof of payment within six weeks. Put up thereafter. |

| Direction issued by the Commission | The Commission vide its proceedings dated 14.12.17 directed to issue a show cause notice u/s 18 of the PHR Act, 1993 to the Govt. of Mizoram through its Chief Secretary requiring it to show cause within six weeks as to why an amount of Rs Three Lakhs as monetary compensation should not be recommended to be paid to the next of kin of the deceased, Shebaram Reang. The DG, Tripura was also directed to submit the outcome of case FIR No. 05/2013 u/s 302/304 IPC registered at PS Damchera (North Tripura) and investigated by CID Tripura within six weeks. However, neither the Chief Secretary, Government of Mizoram has sent any reply to the show cause notice dated 30.01.18 nor DGP, Tripura has sent a report sought vide Commission's communication 31.01.18 IIII date. Registry is directed to (issue reminder to i) the Chief Secretary, Govt. of Mizoram ii) Director General of Police, Tripura to submit their response within four weeks. |
