Proceeding						

The Commission received a complaint dated 30-8-2010 from Shri Suhas Chakma, a human rights activist who has sought the Commission's intervention. It is alleged that on 20-8-2010, a 17 year old boy, Omar Qayoum Bhat s/o Abdul Qayoum Bhat was picked up by the police during a protest. He was detained and tortured at PS Soura in Srinagar, J&K. The said boy died on 25.8.2010 due to the police torture. The complainant has sought necessary action against the delinquent police officials and payment of interim compensation to the next of kin of the deceased.

Vide proceedings dated 24-5-12, the Commission considered the report from the Additional DCP, Srinagar, J&K. It was intimated that during turmoil in the year 2010, the above boy named Umer Qayoom s/o Abdul Qayoom Bhat lost his life on 11-6-11. The Government sanctioned ex-gratia relief of Rs. 5 lakhs each, in favour of next of kins of the deceased persons who lost their lives in the turmoil. No relief was sanctioned in favour of the next of kin of Umer Qayoom as his family members had lodged a case against the security forces for killing him. The family members later on approached the authorities with a request that they would withdraw the case against the security forces if ex gratia relief is sanctioned to them. Consequently, the matter was referred to the Home Department of the State Government, which is pending consideration. The Deputy Commissioner, Srinagar, J&K was directed to send a report whether any ex-gratia monetary relief has been paid to the next of kin of the deceased Umar Qayoom. A complete report of inquest proceedings and final cause of death was also to be sent. Further, an enquiry was to be made from the State Human Rights Commission, J&K, Srinagar, whether they had taken cognizance of the case relating to the death of Umar Qayoom s/o Abdul Qayoom.

In response to the aforesaid directions and further last reminder vide proceedings dated 11-12-12, the Commission has received a communication dated 11/3/13 from the Secretary, Jammu & Kashmir, SHRC that they took cognizance of the complaint filed by the father of the deceased Sh. Ab. Qayoom Bhat on 18-7-11 and has sought factual reports from Secretary to Govt, Home Department / DGP, J&K and DC, Srinagar. However, due to contradictions in the report of Home Department / DGP, J&K and DC, Srinagar, an independent enquiry into the incident was ordered by the SHRC and the case was entrusted to SP, J&K SHRC, who has yet to file the investigation / enquiry report to the Commission. However, he has been given a last opportunity to file his enquiry report by or before 9-4-13. The Commission shall apprise the Apex Body as and when the complaint is finally disposed off after the investigation wing files its report.

The complainant has submitted his comments dated 27/6/13 and has requested that the case may not be transmitted to SHRC and has requested that till date no action has been taken by the State Government to provide financial assistance / ex-gratia relief of Rs. 5.00 lakhs to the deceased's family even though the DC, Srinagar on 13-12-10 had recommended to the Principal Secretary, to the Govt., Home Deptt., J&K to provide exgratia relief of Rs. 5.00 lakhs to the NoK of the deceased.

The Commission has also received a communication dated 11-3-13 from the father of the deceased stating that his son was picked up by J&K, Police. He was tortured and his vital organs were damage and he died on 25/8/10. Till date he has not received any compensation or ex-gratia relief. Intervention is sought for justice.

The Commission has considered the material placed on record and asks:-

- 1. the Secretary, Jammu & Kashmir, SHRC to submit factual report of inquiry conducted by SP, J&K SHRC.
- 2. The Principal Secretary, to the Govt., Home Deptt., J&K to submit a further report as to status of payment of ex-gratia relief of Rs. 5.00 lakhs to the NoK of the deceased. Response within four weeks.
