<b>Proceeding</b>	<p>This is in continuation of the proceedings dated 22.09.2017, wherein the Commission has observed as under:</p> <p>“The petitioner has alleged abduction of his brother, killing of his father, atrocities, harassment by certain persons, non-registration of case and inaction by local police. Let a Notice be issued to the Superintendent of Police, Jaunpur, Uttar Pradesh, calling for report together with compliance of Section 166A I.P.C within four weeks. In the meanwhile, the Director General, Investigation Division of the Commission shall also get the facts collected over telephone and put the same within 3 days.”</p> <p>Pursuant to direction given by this Commission, the Investigation Division had taken up the matter and observed and recommended as under:</p>				

“Analysis of the records & reports reveal the following facts:

1. The complainant alleging abduction an gang rape of a dalit woman by five persons. The matter was reported to the police, and case was registered at Tara Nagar police station, Churu, Rajasthan, vide Cr. No. 310/2017 u/s 376(D) IPC & 3(1)W(I), 3(2)(v) SC/ST Act.
2. During investigation, statement of the victim was recorded u/s 164 Cr.PC in which she denied the involvement of Vinod and Hansraj in the case. However, Banwari Jat the main accused was arrested by the police on 28-11-2017 and sent to Jail.
3. After investigation charge sheet has been filed vide No. 259 dated 27-12-2017 u/s 376, 366 IPC & 3(1)(W)(1), 3(2)(v)SC/ST Act against the accused Banwari Jat
4. A compensation of Rs. 5,12,500/- has been paid to the victim Smt. Sarsawati as financial assistance under SC/ST Act by the order of District Collector, Churu. The proof of payment has been found enclosed with the report.
5. Comments of the victim have not been received till date. No mobile or telephone number is available in the complaint to contact the complainant over the telephone. Non submission of comments by the victim may be presumed that she is not willing to pursue his case any more.

In view of the above facts, considering receipt of the police report and the matter being subjudice, the Hon’ble Commission may kindly consider not to proceed further and closing the case based on the report of SP Churu.”

The Commission has carefully gone through the recommendation of the Investigation Division as well as material on record. Since in this case the accused has been charge-sheeted and sent to Jail and the victim has been given compensation of Rs. 5,12,500/- under SC/ST Act by the District and State Administration by order of District Collector, Churu. therefore, no further action is required in this case. The case is accordingly directed to be closed.
