The complaint/intimation dated 30/10/2019, received from DHANA KUMAR in respect of SUKHDEV SINGH, was placed before the Commission on 22/09/2022. Upon perusing the same, the Commission directed as follows:

The complainant has requested for intervention of the Commission in the matter of death of a convict prisoner Sukhdev Singh, aged 65 years, in the judicial custody of Jaitsar Open Jail, on 29.10.2019.

In response to the directions of the Commission dated 1.8.2022, regarding the payment of compensation of Rs. 5 Lakhs to the NoK of the deceased. A report has been received from the Dy. Secretary, Home (Human Rights) Department, Government of Rajasthan dated 1.9.2022 which discloses that the recommended compensation of Rs. 5 Lakhs has been proposed to be deposited in the bank account of the NoK of the deceased i.e. Sukhdev @ Sukha.

The Commission considered the report. The Chief Secretary, Government of Rajasthan is hereby directed to furnish the proof of the aforesaid payment to the Commission within four weeks.

With the aforesaid direction, the case is hereby closed.

2. Accordingly, you are directed to take further necessary action at your end as per the directions of the Commission.
