Subject: Additional Information Called for -16976/24/28/2020-AD.

Sir/Madam,

I am directed to say that the matter was considered by the Commission on 19/09/2022 and the Commission has directed as follows.:

The Complainant, in the instant case, had made a complaint regarding the death of one under-trial prisoner identified as Robin Verma (40 years) who was in the custody of Temporary jail in Firozabad district of Uttar Pradesh on 27.8.2020. The Commission had also received an intimation from the Superintendent/SDM Sadar, Temporary Jail, Firozabad, Uttar Pradesh regarding suicide by under trial prisoner Robin Verma, S/o Laxmi Narayan Verma, aged 34 years, on 27.8.2020, while in the custody of that jail.

The Commission vide its proceedings dated 29.07.2022 had directed the Chief Secretary, Govt. of Uttar Pradesh to submit compliance report with regard to the proof of payment of monetary compensation of Rs. 3,00,000/- (Rupees Three Lakhs only) to the NoK of deceased prisoner Robin Verma, S/o Laxmi Narayan Verma.

Pursuant to the directions of the Commission, letter dated 16.08.2022 of the Under Secretary, Govt. of Uttar Pradesh has been submitted wherein request has been made to the Special Secretary, Department of Prison, Administration and Reformatory Services, Uttar Pradesh for submission of proof of monetary compensation of Rs. 3,00,000/- (Rupees

Three Lakhs only) to the NoK of deceased prisoner Robin Verma, S/o Laxmi Narayan Verma.

The Commission has considered the letter submitted by the authority in the instant case. In the interest of justice, one last and final opportunity is granted and the Chief Secretary, Govt. of Uttar Pradesh is directed to submit the compliance report with regard to the proof of monetary compensation of Rs. 3,00,000/- (Rupees Three Lakhs only) to the NoK of deceased prisoner Robin Verma, S/o Laxmi Narayan Verma. Requisite report be submitted within four weeks, failing which the Commission would be constrained to issue coercive process U/sec. 13 PHR Act, 1993.

2. It is therefore, requested that the additional/complete report as directed by the Commission in the matter be sent latest by 27/10/2022, for further consideration by the Commission.
