Three Lakhs and Seventy Five Thousand only) to the NoK of the deceased under trial prisoner Pramod s/o Kuldeep Issue from the Chief Secretary, State of Haryana in terms of directions dated 7.7.2021, 26.10.2021 and 12.2.2022 of the Commission. Issue final reminder to the Chief Secretary, State of Haryana for submission of compliance report along with proof of payment of Rs. 3,75,000/- (Rs. Three Lakhs and Seventy Five Thousand only) to the NoK of the deceased under trial prisoner Pramod s/o Kuldeep, within a period of four weeks failing which the Commission shall be constrained to invoke its coercive power u/s 13 of the PHR Act, 1993 calling for the personal appearance of the authority concerned before the Commission. Registry to transmit copy of directions dated 7.7.2021, 26.10.2021 and 12.2.2022 of the Commission along with this direction." No communication is received since 23.09.2021. In view of the same, Registry is directed to issue a fresh reminder to the Chief Secretary, State of Haryana as well as Additional Chief Secretary, Jail Department, Haryana for submission of compliance report along with proof of payment of Rs. 3,75,000/- (Rs. Three Lakhs and Seventy Five Thousand only) to the NoK of the deceased under trial prisoner Pramod s/o Kuldeep, within a period of four weeks failing which the Commission will be constrained to invoke its coercive powers u/s 13 of the PHR Act, 1993."
