With reference to your complaint/intimation dated 13/05/2020. I am directed to say that the matter was considered by the Commission on 21/07/2022. The Commission has made the following directions:

The Commission has received a complaint from Shri Dhana Kumar from Campaign Against Torture (CAT) regarding custodial death of one, Aman Agarwal, on 12.05.2020, under suspicious circumstances in the judicial custody at Lucknow district jail, Uttar Pradesh.

Perusal of the CMIS record reveals that another Case No. 9947/24/48/2020-JCD is pending in the Commission in respect of custodial death of the deceased Aman Kumar who died on 12.5.2020 in judicial custody at the District Jail, Lucknow, UP.

Let this matter be linked with Case No. 9947/24/48/2020-JCD which shall be treated as main case as the Commission had recommended compensation of payment of Rs. 4,75,000/- to the NOK of the deceased Aman Kumar vide proceeding dated 21.6.2022.

No further proceeding in the present case is required.

Let this matter be linked with Case No. 9947/24/48/2020-JCD.
