Sir/Madam,

With reference to your letter no. dated , I am directed to say that the matter was considered by the Commission on 07/09/2022 and the Commission has directed as follows.

*In the instant case which relates to the death of one Babu Das due to torture by police of P.S. Rakshasmari District, Sonitpur, Assam on 23.8.2019, the Commission issued notice u/s 18 of the PHR Act, 1993 to the Govt. of Assam to show cause as to why compensation of Rs. Seven Lacs should not be granted to next of kin of the deceased who died as a result of police torture. The Commission on 26.4.2022, while considering the reply to the show cause notice submitted by Joint Secretary to Govt. of Home & Political Department, Dispur vide letter dated 10.02.2022 to either waive of or reduced quantum of compensation proposed by the Commission as the deceased was a chronic alcoholic and died due to 'septicaemic and his death was not directly attributed to physical assault by the police and also that the investigation of FIR No.608/2019 P.S Dekiajuli is being transferred to CB CID for investigation, directed DGP, Assam to submit the status report to the Commission regarding transfer of investigation within six weeks. No response has been received from DGP, Assam, so far about the status of CB CID investigation of the incident arising out of FIR No.608/2019 P.S Dekiajuli Issue reminder to DGP, Assam to ensure that the CB CID investigation is expeditiously completed and furnish the report of CB CID investigation to the Commission within eight weeks. The complainant has also not submitted his comments on the report dated 10.2.2022 submitted by Joint Secretary, Home & Political Department, Govt. of Assam, which was sent to him by Commission's letter dated 17.5.2022. Issue reminder to the complainant returnable within eight weeks. List after eight weeks.*

2. It is therefore, requested that the additional/complete report as directed by the Commission in the matter be sent latest by 03/12/2022, for further consideration by the Commission.
