Sir/Madam,

I am directed to say that the matter was considered by the Commission on 02/03/2022 and the Commission has directed as follows.:

***The complainant, vide online complaint dated 21.06.2021, has informed the Commission about death of 45-year-old woman identified as Yesumma,19.06.2021 due to the alleged custodial torture at Addagudur PS, District-Yadadri, Telangana.***

***The Commission vide its proceedings dated 06.12.2021 had directed the registry to issue fresh reminder to the Commissioner of Police, Rachakonda, Commissionerate, Hyderabad, Telangana as well as District Collector, YadariBhuvanagiri, Telangana to submit the English translation of the documents already sent in regional language. They were further directed to submit the remaining requisite reports including judicial MER in the matter.***

**Pursuant to the directions of the Commission, a report dated 10.12.2021 of the Commissioner of Police, Rachakonda, Commissionerate, Hyderabad, Telangana has been submitted case has been registered and the Disciplinary Authority of Rachakonda Police Commissionerate passed orders imposing exemplary punishment of "dismissal from service" against the then SHO of Addagudur PS namely V. Maheshwar and also against two police constables. The State Govt. has released Rs. 15,00,000/- to the son of the deceased Sri Uday Kiran and Rs. 10,00,000/- each to the two daughters of the deceased viz. Kasimalla Swapna and Inukonda Sulatha apart from appointing Sri Uday Kiran as office subordinate in Social Welfare Department, Khammam District. It is submitted that after collecting the post mortem report and Judicial Magistrate Enquiry Report, further investigation will be completed and on conclusion of investigation, the charge sheet will be filed in the concerned Jurisdiction Court for prosecution of the accused in Cr. No. 63/2021 of P.S. Addagudur.**

**The Commission has considered the report submitted by the authority in the instant case. The Commissioner of Police, Rachakonda, Commissionerate, Hyderabad, Telangana as well as District Collector, Yadari Bhuvanagiri, Telangana are directed to submit the Magisterial Enquiry Report along with residue reports (in English language) in the instant case. Requisite report be submitted within six weeks, failing which the Commission would be constrained to issue coercive process U/sec. 13 PHR Act, 1993.**

2. It is therefore, requested that the additional/complete report as directed by the Commission in the matter be sent latest by 23/04/2022, for further consideration by the Commission.
