Subject: Concluded and No Further Action Required(CLD) -279/6/15/2020-PCD.

Sir/Madam,

With reference to your complaint/intimation dated 14/02/2020. I am directed to say that the matter was considered by the Commission on 19/04/2022. The Commission has made the following directions:

The present case relates to the allegation of the complainant regarding death of a 17-year old minor boy identified as Chirag Chauhan s/o Mukesh Chauhan due to torture in police custody of Mehsana PS at Mehsana Civil Hospital, Gujarat on 13.02.2020. Hence, intervention of the Commission was sought for in the matter.

The Commission vide proceedings dated 31.01.2022 had, after considering the reply to the show cause notice, confirmed its recommendation made u/s 18 of the Protection of Human Rights Act, 1993 for payment of compensation of Rs. 4,50,000/- (Rs. Four Lakhs Fifty Thousand only) to the NoK of the deceased Chirag Chauhan s/o Mukesh Chauhan who died due to torture by observation home officials on 13.02.2020. The Chief Secretary, Government of Gujarat was directed to submit the compliance report, along with proof of payment within six weeks positively, failing which the Commission shall be constrained to invoke provision u/s 13 of the Protection of Human Rights Act, 1993.

In response to the above directions, the Superintendent of Police, Mehsana, Gujarat has submitted the compliance report dated 23.03.2022 wherein it has been stated that the compensation amount of Rs. 4,50,000/- (Rs. Four Lakhs Fifty Thousand only) has been paid by way of cheque No.095359 on 22.03.2022 to the NoK of the deceased Chirag Chauhan s/o Mukesh Chauhan. Copy of receipt of payment from NOK has also been enclosed with the report.

In view of the compliance of the recommendations of the Commission by the State Government of Gujarat and no further action is pending, the case is closed.
