Subject: Concluded and No Further Action Required(CLD) -2728/12/10/2020.

Sir/Madam,

With reference to your complaint dated 09/12/2020. I am directed to say that the matter was considered by the Commission on 28/06/2021. The Commission has made the following directions:

The instant complaint is regarding allegation of death of one 25-year-old Dalit youth identified as Devraj Anuragi on 07.12.2020 due to beating by two non-Dalit persons in an area under Kishanpur village, District-Chhatarpur Madhya Pradesh. It is alleged that on 07.12.2020, the victim was called by two non-Dalit persons identified as Bhoora Soni and Santosh Pal for cleaning after a party in Kishanpur village. The two got angry, when they noticed Devraj Anuragi (the victim) was eating food and started beating him with sticks due to which the victim died on the spot. He has requested intervention of the Commission.

The Commission vide its proceedings dated 05.04.2021 had directed the registry to issue reminder to the Superintendent of Police, Chhatarpur, Madhya Pradesh for submission of requisite report in the instant case.

Pursuant to the directions of the Commission, a report dated 13.04.2021 has been submitted by the Superintendent of Police, District Chatarpur, Madhya Pradesh. It is reported that compensation of Rs. 8,25,000/- has been approved vide order dated 11.12.2020. The same is electronically remitted to Kallu Anuragi, S/o Late Sh. Binda Anuragi. Charge sheet no. 56/2021 dated 06.03.2021 has been submitted for the offence U/sec. 302/34 IPC and section 3(2)(v) SC/ST Act before the Hon'ble Court.

Since the investigating officer has investigated the case, submitted chargesheet in the matter and the law will take its own recourse, no further intervention of the Commission is

required.

The case is closed.
