A reply dated 8.9.2022 to the show cause notice u/s 18 of the Protection of Human Rights Act, 1993 has been received from the OSD cum Special Secretary, stating therein that monetary compensation of Rs. 3,25,000/- has already been recommended in NHRC Case No. 1573/18/3/2020-JCD for the same incident and it is further requested additional recommendation for payment of Rs. 5 lakhs to the NOK of the deceased may not be fastened. The Commission has perused and considered the report. In view of the fact that NHRC has already recommended the compensation of Rs. 3,25,000/- in NHRC Case No. 1573/18/3/2020-JCD. No further intervention of the Commission is required in the present case. In view of the above, the case is hereby closed.
