Proceeding	The Complainant, who is coordinator of Campaign Against Torture(CAT), in his online			
	complaint dated 06.04.2020 has alleged about the death of four persons including a 1-			
R	year-old child in forest fire near Araliyuthu under Rasingapuram forest range in Theni			
	District of Tamil Nadu when they were returning home on foot due to nationwide			
	lockdown due to COVID-19 on 24 March 2020. They were employed at Pethotty			
	Cardamom Estate in Idukki district of Kerala and were returning to their native place			
	Rasingapuram along with other labourers. The deceased had been identified as Ms			
	Maheswari (40), Ms V. Manju (35), Ms K. Vijayamani (45) and her 1-year-old			
	granddaughter T. Krithika. The Complainant has urged the Commission for intervention			
	and for direction to the State Govt. for conducting judicial enquiry and for compensation			
	to NOK of the deceased. The Commission vide its proceeding dated 16.10.2020 had			
	issued final reminder to the District Collector, Theni, Tamil Nadu for submission of			
	requisite report. The report should clearly specify whether any ex-gratia compensation has			
	been paid to the NOK of the deceased persons. Pursuant to the directions of the			
	Commission, a report dated 14.10.2020 has been submitted by the District Collector,			
	Theni. It is reported that 10 tea estate labourers, who worked in the Pethotty Cardamom			
	Estate of Kerala were returning to their home village on 24.03.2020 despite nationwide			
	lockdown. On 24.03.2020 at 2 pm, there was a sudden break out of forest fire, and in the			
	fire accident, four persons died on the spot. Other six persons were rescued and given due			
	medical care, who have returned to their home after medical treatment. It is submitted that			
	all the 10 persons have violate the law in-force. The Government of Tamil Nadu, on			
	compassionate ground have disbursed an ex-gratia of Rs. 4 Lakhs each to the NoK of the

deceased as compensation. It is submitted that the Government has already granted compensation to the victims, hence, the request of the complainant may be rejected. Since, the concerned Government has already granted compensation to the victims of the alleged incident, who had though violated the lockdown rules, no further intervention of the Commission is required in the present case. The case is closed.
