I am directed to say that the matter was considered by the Commission on 27/09/2010 and the Commission has directed as follows.

These proceedings shall be read in continuation to the commission proceedings dated 6th July, 2010.

In response a letter dated 28th July, 2010 has been received from Collector and District Magistrate, Guntur. Perusal of the same reveals that an amount of Rs. 20,000/- has been sanctioned to be paid to Smt. Asodi Ramanammaa wife of Late Asodi Nagi Reddy.

The commission has considered the reply. An amount of Rs. 20,000/- has been sanctioned as interim relief to be paid to Smt. Asodi widow of the deceased. The commission feels that the amount sanctioned is on the lower side. In these circumstances the commission recommends payment of Rs. 1,00,000/-(Rupees One Lakh only) as interim relief to Smt. Asodi Ramanamma widow of the deceased Chief Secretary, Govt. of Andhra Pradesh, Hyderabad is directed to send proof of payment made to Smt. Asodi Ramanamma, after deducting Rs 20,000/-, if already paid. Response in eight weeks.

It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 01/12/2010, so that the same could be placed before the Commission.
