With reference to your complaint dated 12/01/2011, I am directed to say that the matter was considered by the Commission on 21/06/2012. The Commission has made the following directions.

These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 19th April, 2012.

In response, the Deputy Secretary, Home Department, Government of Jharkhand vide his communication dated 28th May, 2012 has submitted the report. Perusal of the same reveals that an amount of Rs.5,00,000/- (Rupees five lakhs only) as recommended by the Commission has been paid to Smt. Somiya Chhetri, wife of the deceased on 21st may, 2012. The proof of payment has also been annexed.

The Commission has considered the matter. The amount of interim relief as recommended by the Commission has been paid to the next of kin of the deceased. The Chief Secretary, Government of Jharkhand is directed to see that the departmental proceedings against Inspector Ramesh Kumar Singh, the then SHO, PS Musabani and Assistant Inspector, Raj Bihar Yadav, Investigating Officer, are finalized expeditiously. With these directions, the compliance report is taken on record and the case is closed.

The copy of this proceeding be forwarded to the Information Officer, NHRC and the recipient of the amount.

I am directed to say that the matter was considered by the Commission on 07/03/2012 and the Commission has directed as follows.

The Commission has considered the reply. The Government of Jharkhand has no objection to the grant of monetary relief to the next of kin of the deceased Damar Bahadur. An amount of Rs. 5,00,000/- (Five Lacs only) is recommended to be paid as monetary relief to the next of kin of the deceased. Chief Secretary, Government of Jharkhand, Ranchi is directed to send the proof of payment made to the next of kin of the deceased to the Commission within four weeks.

It is therefore, requested that the compliance report in the matter be sent to the Commission latest by 17/04/2012, so that the same could be placed before the Commission.
