Sir/Madam,

With reference to your complaint dated 11/10/2010, I am directed to say that the matter was considered by the Commission on 01/05/2013. The Commission has made the following directions.

In an unfortunate incident, three policemen and five civilians including three students died. Five students sustained serious injuries and five students sustained simple injuries. Now, the Commission is informed that NOKs of five civilians, namely, (i) Smt. Damayanti Jairam Gawde, age 45 years, Govt. Ashram School, Sawargaon, Distt. Gadchiroli; Manguram Ladaghu Marapi, age 70 years, (ii) Sawargaon, Tah. - Dhanora, Distt. Gadchiroli; (iii) Sunil Vishalsing Halami, age 8 years, R/o Gajamendhi, Tah. -Dhanora, Distt.- Gadchiroli; (iv) Nangsai Manker Hidko, age 9 years, R/o Rampur, Tah - Dhanora, Distt. Gadchiroli; and (v) Mukesh Parshuram Potavi, age 7-years, R/o Markegaon, Tah - Dhanora, Distt. Gadchiroli have been provided the relief of Rs. 1.00 lakh each under SRE Scheme and Rs.3.00 lakhs each under Central Government Scheme, namely, Central Scheme for Assistance to civilians victims of terrorists, communal and nexal violence. About eleven persons in all who sustained grievous injuries and minor injuries were paid sum of Rs. 75,000/- and Rs.25,000/- each accordingly. The list of the persons is as under:
