Sir/Madam,

With reference to your complaint dated 16/07/2003, I am directed to say that the matter was considered by the Commission on 25/02/2011. The Commission has made the following directions.

"These Proceedings shall be read in continuation of the earlier Proceedings dated 15.11.10 of the Commission, wherein it observed and directed as follows:

"Requisite reports are awaited.

In these Circumstances, the Commission directs as under:-

- 1) Chief Secretary, govt. of Karnataka be reminded to submit proof of payment of the amount Rs. 20,000/- to the victim Smt. Kamla Bai, within six weeks failing which the Commission shall initiate proceedings u/s 13 of the PHRA Act, 1993.
- 2) DGP, Karnataka be reminded to transmit out come of the departmental enquiry proceedings initiated against 5 police personnel including Shri. E.S. Veerabhadraiah, CPI, within six weeks failing which the Commission shall initiate proceedings u/s 13 of the PHRA Act, 1993.
- 3) Superintendent of Police, Gulbarga, Karnataka be reminded to transmit present status of the Crime Case No. 81/08 u/s 323/324/504 r/w34 IPC and u/s 3(1) (X) SC/ST (POA) Act, 1989 which was submitted in the Court, within six weeks failing which the Commission shall initiate proceedings u/s 13 of the PHRA Act, 1993.

In response to the notices dated 09.07.10, the Chief Secretary, Govt. of Karnataka sent a communication dated 22.12.10 along with the proof of payment of Rs. 20,000/- made to the victim Kamla Bhai, as monetary relief.

The Commission has received another communication dated 24.12.10 from Director General and Inspector General of Police, Karnataka which reveals that the departmental enquiry initiated against Sri. E. S. Veerabhadraiah, CPI, Ari. Balavanta Reddy, CPC, Sri. Revanna Siddappa, CPC, Sri. Bhanu Das, CHC and Sri. Mallinatha, CHC of Chittapura Police Station has been completed and since the charges leveled against them are not proved, they were exonerated. In Crime Case No. 81/08 registered w/s 323/324/504 r/w 3(1) (x) SC/ST PA Act 1989, the Court has accepted the B Final report.

The reports are taken on file. The case is closed."
