Direction issued by the Commission	In response to its proceedings of the 19th December 2012, the Commission has received an endorsement of a letter dated the 17th January 2013, from a Deputy Secretary of the State Government to the Secretary of the Home Department, but no substantive response. The Commission takes it that the Government of Madhya Pradesh has no comments to offer. Therefore, for the reasons recorded in detail in its earlier proceedings, the Commission asks the Government of Madhya Pradesh to pay Rs. 1 lakh as relief for the next of kin of the late Pawan @ Bhaiya. Proof of payment is expected by the 11th April, 2013. Put up on the 18th April, 2013.
