With reference to your complaint dated 15/12/2008, I am directed to say that the matter was considered by the Commission on 27/11/2014. The Commission has made the following directions.

"In this case, the recommendation to pay compensation to the wife of deceased Rajpal Bawaria had already been complied with and proof of payment had been submitted to the Commission. Regarding the recommendation to take disciplinary action against Inspector Jagat Singh, the Commissioner of Police, Faridabad, vide communication dated 3.9.2014 has submitted that a regular departmental enquiry has been initiated against Inspector Jagat Singh vide order dated 15.7.2014 and that the enquiry is being conducted by Assistant Commissioner of Police, Mujeser, Faridabad. Therefore, no further direction is called for. The case is closed."

Direction issued by the Commission

In the proceedings dated 7.8.13 this Commission recommended to the Government of Haryana to pay a sum of Rs. Three Lakhs as monetary relief to the next of kin of deceased Rajpal Bawaria and the Chief Secretary Government of Haryana was directed to submit compliance report with proof of payment within eight weeks. The Commission also recommended to the Director General of Police, Haryana to initiate departmental action against Inspector Jagat Singh of CIA and award him suitable punishment, if any. He was also directed to submit the action taken report within eight weeks. It is seen that the Addl. Chief Secretary to Government of Haryana (Home Dept) had vide his communication dated 10.10.2013 informed the Director General of Police, Haryana that the Governor had accorded sanction to pay an amount of Rs. Three lakhs as monetary relief to the next of kin of deceased Rajpal Bawaria as recommended by the Commission. The Addl. Chief Secretary had also directed the Director General of Police, to disburse the compensation to the next of kin concerned and to send the proof of payment to the Commission at the earliest. However, no report has been received from the Director General of Police, Haryana, Panchkula, either regarding the disciplinary action against Inspector Jagat Singh or regarding the proof of payment of compensation to the next of kin of the deceased. Therefore, Director General of Police, Haryana, Panchkula is reminded to furnish the above information within four weeks. Put up after six weeks.
