Sir,

With reference to the above, I have the honour to submit as follows:-

That a proposal was received from Deputy Commissioner, Karbi Anglong District for sanction of ex-gratia to next of kins of Parboti Teronpi along with two others who were killed in police firing. However, The, Deputy Commissioner did not enclose the post mortem reports due to which the proposals could not be processed.

That the DC Karbi Anglong was requested to submit the post mortem reports. That the DC submitted only one post mortem report out of three cases and intimated that the other two post mortem reports would be submitted as soon as received from the concerned authority.

That as DC remained silent for quite some time, he was reminded to expedite submission of post mortem reports.

That the DC Karbi Anglong endorsed a copy of report sent to Hon'ble NHRC in connection with case No 190/3/8/08-09/M-1which was received on 16.6.2010. The matter was processed immediately as per procedure and the matter was placed before the competent authority i.e. Hon'ble Chief Minister for favour of approval. The necessary sanctions as per annexure I was issued on 13th September, 2010 as soon as the approval of Hon'ble Chief Minister was received.

- 6. That regarding the sanction of financial assistance to the injured persons though a proposal was received from DC Karbi Anglong, it did not contain the required documents for which the same had to be returned for resubmission. After receipt of all necessary documents, the matter was processed and the sanction was issued vide annexure II.
- That as of now the directions of NHRC has been fully complied with and the sanction orders issued in this regard are enclosed at Annexure I and Annexure II
- That the undersigned has the highest regard for National Human Rights
  Commission and its directions and seek unconditional apology for the
  inconvenience caused to the Commission.
