With reference to your letter no. dated 13/05/2008, I am directed to say that the matter was considered by the Commission on 25/04/2008 and the Commission has directed as follows:

Suhas Chakma, Director of Asian Centre for Human Rights, New Delhi sent a representation to the Commission referring an incident of killing one civilian named Sinam Devan and causing of injuries to Laishram Sanit, Sapam Prakash and two personnel of Manipur Rifles named Ngamjatong Haokip and R.K. Bobby in an attack by unidentified mutants on the security forces, Imphal at 6.30 p.m. on 10.1.05,

The Commission took cognizance on 11.2.2005 and issued notice to DGP and Chief Secretary, Manipur calling the report within four weeks.

Pursuant to the notice of the Commission, the Joint Secretary (Home), Govt. of Manipur vide his communication dated 3.4.06 confirming the factum of such incident of militant attack submitted that ex-gratia amount of Rupees one lakh and Rupees Ten thousand have been paid to the next of kin of the deceased (L) S. Devan Singh and (L) Ranjit Singh injured respectively. No other injured person has made a claim. The Magistrate in the enquiry report held the UG activists responsible for the incident.

The Commission vide proceedings dated 2.1.07 considered report and directed as under:

"Let the copy of the report be sent to the petitioner for comments, if any, within four weeks.

Joint Secretary Home Govt, of Manipur be asked to submit the proof of factum of payment of ex-gratia relief as said in his communication and further report with respect to other injured persons within four weeks."

Neither comments on earlier report have been received nor further report has been received from the Govt. of Manipur.

Neither comments on earlier report have been received nor further report has been received from the Govt, of Manipur.

Issue final reminder to the complainant as well as the Government of Manipur.

Response in tour weeks.

2. It is therefore, requested that the additional/complete report as directed by the Commission in the matter be sent latest by 17/05/2008, for futher consideration by the Commission.
