*We have now received a communication dated 9.12.2013 that the Government of Bihar, after accepting our recommendation, has paid the monetary relief of Rs.1.00 lakh to the next of the deceased. Proof of payment has also been enclosed therewith.*

*Since the Government of Bihar has complied with the recommendation of the Commission nothing further needs to be done in the matter. Therefore, we order closure of this case along with all the connected matters.*

Direction issued by the Commission	These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 12.7.2013. In response, Special Secretary, Home (Special) Department, Government of Bihar, vide her communication dated 23.7.2013, has informed the Commission that an amount of Rs.1,00,000/- (Rupees One Lakh only), as recommended by the Commission, has been placed at the disposal of District Magistrate, Siwan, Bihar for payment to the next of kin of the deceased Govind Rajbhar. The Deputy Secretary, Home(Special) Department, Government of Bihar, vide his communication dated 3.6.2013 has also informed the Commission that Sub Inspector Sanjiv Kumar has been placed under suspension and departmental proceedings have been initiated against him. It has been further stated that Home Guard Shankar Singh, who has also been found guilty, has been debarred from duty for one year. The proof of payment has, however, still not been received. The Commission has considered the matter. Let a Notice be sent to the District Magistrate, Siwan, Bihar calling upon him to submit the proof of payment made to next of kin of the deceased within six weeks. Let a Notice be also sent to the Special Secretary, Home (Special) Department, Government of Bihar calling upon her to submit the outcome of the departmental action initiated against the delinquent police personnel within this period.
