Proceeding

The complainant Shri Dhana Kumar, Coordinator, Campaign Against Torture, New Delhi has alleged that one Raju, who belongs to Scheduled Caste community was tortured by the police of Bichhwan Police station where he went to lodge complaint about abduction of his wife by three unidentified persons from the Aligarh-Kanpur highway on the night of 05.07.2019. Hours later the wife of the victim reported to the police that she had been gang raped after abduction. The complainant has sought intervention of the Commission for judicial inquiry, legal action against all the police officials and payment of compensation to the victims.

The Commission took cognizance of the matter on 23.07.2019 and transmitted a copy of the complaint to the Superintendent of Police, Mainpuri, Uttar Pradesh calling for an action taken report within 4 weeks.

The Commission also sought to obtain the date of cognizance of the complaint by UP State Human Rights Commission. However, no response has been received from the State Commission so far.

Pursuant to the directions of the Commission, the Superintendent of Police, Mainpuri, UP has filed the report dated 27.11.2019, along with the report of Circle Officer, Kurawali, District Mainpuri dated 09.11.2019. The report reveals that on the complaint of complainant Shri Raju S/o Shri Surajpal Singh a crime case No.257/2019 u/s 376D/364/392 IPC dated 06.07.2019 was registered at PS Kurawali against unknown persons. During investigation the name of accused persons Anil Kumar @ Amit Kumar, Sheelendra and Lalu @ Satendra came to light. Accused Anil Kumar @ Amit Kumar and Sheelendra were arrested by the police of PS Pilua, District Eta on 09.07.2019. Section 411 IPC and Sec.3(2)5 SC/ST Act were added. One 325 bore revolverand 02 box cartridges and 08 live cartridges 315 bore and one Apache motor cycle without number and one pair anklets and looted Rs.4940 were recovered from accused Lalu @ Satendra. FIRs were registered at PS Kurawali vide No.267/2019 u/s 307 IPC and 268/2019 u/s 3/25/27 Arms Act were registered regarding police encounter. During investigation of case FIR No.267/2019 since offence u/s 307 IPC was proved, charge sheet No.275 dated 06.09.2019 and in case FIR No.268/2019 u/s 3/25/27 Arms Act vide charge sheet No.267 dated 09.08.2019 were submitted against Lalu @ Satendra. In case FIR No.257/2019 u/s 376D/364/392/411 IPC and u/s 3(2)5 SC/ST Act, charge sheet No.267 dated 29.08.2019 was submitted.

The report further reveals that on the basis of the complaint of complainant Raju S/o Surajpal regarding assault on him another case FIR No.260/2019 dated 07.07.2019 u/s 307/323/504 IPC and Sec.3(2)5 SC/ST Act was registered at PS Kurawali against the then SHO and three unknown constables. During investigation by Circle Officer Kuawali names of the then SHO Bichvon Shri Rajesh Pal Singh and Constables Krishnavir Singh and Chatrapati came to light. Accused suspended SHO Rajesh Pal Singh through Criminal Writ Petition No.19934/2019 obtained stay of his arrest and accused Constables Krishnavir Singh and Chatrapati got stay order from their arrest from High Court of Allahabad in Writ Revision No.20259/19 dated 06.08.2019. During investigation, offences u/s 307 IPC and Sec.3(2)5 SC/ST having found not established were dropped and offence u/s 3(1)da-gha SC/ST Act having found established were added.On investigation since offences u/s 323/504 IPC and Sec.3(1)da-ghawere established charge sheet No.332/2019 dated 02.10.2019 was submitted againstSHO Shri Rajesh Pal Singh and Constables Krishnavir Singh and Chatrapati. Besides, an amount of Rs.50,000/- as financial assistance has been paid to the complainant Raju S/o Surajpal under SC/ST Act.

The Commission has perused the record and observes that in view of the reports, the charge sheets have been filed in all the three cases before the Court and financial assistance of Rs.50,000/- has been paid to the complainant Raju. But the report is silent about the payment of immediate monetary relief to the complainant's wife Smt. Rooma Devi and whether any departmental action has been taken against the delinquent police officials. The Commission therefore directs the Superintendent of Police, Mainpuri to submit further report about the payment of monetary relief if any to the victim Rooma Devi in PS Kurawali case FIR No.257/2019 u/s 376D/364/392/411 IPC and u/s 3(2)5 SC/ST Act and departmental action, if any, taken against the delinquent police officials namely SHO Shri Rajesh Pal Singh and Constables Krishnavir Singh and Chatrapati, within four weeks.
